Regular Village Board Meeting January 17, 2017

The regular semi-monthly meeting of the Board of Trustees of the Village of Menands, held on Tuesday, January 17<sup>th</sup>, 2017 was called to order by Mayor Megan Grenier at 6:00 P.M.

Open Forum:

Resident Bill Garvey thanked the Ladies Auxiliary for the ham dinner and allowing him to help. He is also concerned about street lights on Harts Lane.

Resident Emma Conway was concerned about Price Chopper closing and what could be done about it. She was also concerned that seniors and residents of Schuyler Inn won't have a store to go to without having to drive to one.

Resident Brian Marsh asked if the Village was aware why Price Chopper was leaving. The Mayor advised that Price Chopper had upgraded other stores around Menands and that they did not own the property.

Resident Marsh also had questions about Economic Development a discussion followed.

Resident Kirk Montanye questioned that if the Village has known for two years that Price Chopper may be leaving what has the Village done.

Trustee Boulet explained that Price Chopper does not own the property and some steps the Village is doing a discussion followed.

Resident James Sher asked what businesses the Village has approached a discussion followed.

The Mayor stated businesses have told her that the Village needs to increase its census.

Resident Kirk Montanye asked if the Village has reached out to any outside agencies to expand the Village's Business Base a discussion followed.

Resident Sher stated he read on the internet that Rite Aid was bought out by Walgreens and the Menands Store will be closing by the end of the year. The Board stated they have not heard that.

Resident John Stangle stated the website has not been updated in over a year. Website needs to have minutes posted within 14 days after the Board Meetings. The website information is out dated a discussion followed.

Resident Kirk Montanye was concerned that businesses looking to come into Menands looking at the website they would get wrong information about the Village.

James Sher asked about new apartments that will be replacing the bowling alley. The Mayor advised no plans have been submitted at this time.

Resident Josh Montanye advised that there are pot holes on Glenwood Road and a tree has fallen behind 13 Glenwood Road. The Clerk will ask DPW to look into it.

Eric Johnson from Chazen Companies led a discussion about different options for the Community Development Block Grant for the Hendrick Avenue Project.

Option #1 - Would be to complete the engineering study for Hendrick Avenue only at a cost of \$23,900 less the \$10,000 Grant the Village cost is \$13,900.

Option # 2 - Would be to complete the engineering study for Hendrick Avenue, Hampton Avenue, Highland Street, Pawling Street and Kingston Street. The cost of \$56,300 less the \$10,000 Grant the Village cost would be \$46,300.
