QUIET ZONE IMPLEMENTATION NOTICE

The Village has been engaged in the process of establishing a Partial Quiet Zone for railroad crossings on Cemetery Road, Menand Road, Brookside Avenue and Simmons Lane. We are pleased to notify you that the Partial Quiet Zone will take effect on December 7. 2020. When the Partial Quiet Zone is implemented, trains will no longer sound a warning horn when approaching these intersections between the hours of 10:00 pm and 7:00 am except in emergency situations.

In preparation for the establishment of the Partial Quiet Zone, the Village evaluated each railroad crossing and installed new striping and signage. Each railroad crossing is now equipped with stop bars, railroad crossing striping, railroad crossing signage and Quiet Zone signage which reads:

NO TRAIN HORN 10 PM - 7 AM

Residents are advised to observe the new striping and signage and to exercise caution at railroad crossings particularly during the new Quiet Zone hours. The Village is glad for the opportunity to work with

To provide you with the best service possible, the Department of Public Works (DPW) would like to remind everyone that your cooperation is needed during the winter months for proper plowing, salting and snow removal. If you have a driveway or an off street parking space, please use it during the winter months and especially during a snow or ice storm as vehicles parked on the street hinder plowing operations. Please do not put snow in the streets once the plows have gone through. Additionally, anything that you might have in the Village's right-of-way, such as a basketball hoop, should be moved and stored for the winter. The Village will not be responsible for damage to any items left in the Village's right-of-way. In the event that a snow emergency is declared, details will be provided to local news stations, on the Village website and through our emergency alert system.

LIBRARY MANAGER (FULL TIME) MENANDS PUBLIC LIBRARY

The Board of Trustees of the Menands Public Library seeks an enthusiastic and community-oriented individual to serve as Library Manager to oversee the library in the Village of Menands. The Menands Public Library is a school district public library and is a member of the Upper Hudson Library System. The Library Manager reports to a five-member board of trustees and collaborates with the library board on a variety of activities related to delivering library service to our community. The Library Manager has primary responsibility for the operation and management of the library, including but are not limited to: collection development, customer service, program planning and implementation, utilization of technology to enhance library services, written monthly updates to the board, public relations and community outreach. The Library Manager supervises a small staff of up to five part-time employees. The position of Library Manager is provisional and permanent appointment is contingent upon passing the Library Manager Albany County Civil Service exam and being reachable on the eligible list for that title. Minimum qualifications for this position include completion of sixty (60) credit hours from a regionally accredited or New York State registered college or university and one (1) year of professional experience in administering not-for-profit, government, education, human services, or library services. Equivalent volunteer work in a library can be substituted for professional experience. The Library Manager's annual salary will be \$40,000 - \$44,000 based on the selected candidate's skills and experience. The compensation package also includes participation in the New York State Retirement System. The projected start date for this position will be February 14, 2021.
