VILLAGE OF MENANDS ZONING BOARD OF APPEALS CORRECTED INFORMATION

A public hearing continuation will be held on Thursday, February 17th, 2022 at 6:00 P.M. in the Court Room at 250 Broadway, located on the second floor. This date change has been requested by the applicant.

Vertical Bridge REIT, LLC has proposed a "Vertical Bridge" (cell phone tower) 15 Elmwood Road Extension A.K.A. 381 Broadway zoned in the Broadway Business District (BBD). They are applying for a Use Variance for this proposed project.

The Village Schedule of Use Regulations, Chapter 169, Schedule "A" does not recognize the proposed tower as a "principal use permitted by right or a use permitted by special permit".

In addition, Proposed Development for Daughters of Charities Ministries of St. Vincent DePaul. They are applying for a Use and Area Variance for this proposed project for development of independent and assisted living units, memory care units and 60 cottages. Daughters of Charities Ministries is located in an "R" Zone. Chapter 169 Schedule "A" does not list the proposed development as a "Principal Use Permitted by Right" or a "Use Permitted by Special Permit" therefore

Also, Chapter 169 Schedule "B" stated in an "R" Zone the maximum Building Height is 35' and the number of stories is 2 ½. The primary building height is 79' and exceeds 2 ½ stories.

is not allowed in a "R" Zone.

Such public hearings are open to the public and are accessible to the handicapped. All are encouraged to attend or to present comments in writing.
